It is stated that the PRETERANTURLAS and Earth Physicals, as Well as CONGREGATION of the ASTARITEFAITH,and the-BODY ofHUMANKIND,Do Not Own Not One THING,Not One Iota of theASTARITEFAITH andFIGHT, My,REBECCATACOSAGRAY, CALIFORNIA'S SACREDTEXTS and My SACRED BELONGINGS, The ASATRU and TheLOVESONGofTHEALPHA AND OMEGA,EXACT, The LOCATIONS of VENTURA STREET: ELISELLE[WhichisMyself,REBECCATACOSAGRAY, CALIFONRIAA-LONE]/TheASTARITEFAITHCHURCH&MyHOME, and the GARDEN LOCATION/SonoraStreetCommunityGarden, and All PLACES of LIGHT, PLACES of BEAUTY, and SACRED PLACES.

#### Statement of the Case [Information]

Plaintiff REBECCATACOSAGRAY,CALIFORNIA has requested Physical Acknowledgement of the Work known as TheASTARITEFAITH, TheASATRU [The SACRED TEXT of The ASTARITEFAITH, FIGHT., TheSWORDof TRUTH [A Practical Handbook for Fighting Evil], and The SWORD [In Progress to Be-Planned- Support Work, REBECCATACOSAGRAYCALIFORNIA-PLACELOCATIONEXPERT, TACOSAGRAYART&COMPOSITIONS, and Various Works of Literature and Albums [PALE GLASS SKY and Others]. This Action of Enforcement of Judgment Upon My Work, to Determine it outright to be Exactly Mine, as it exactly is, which I can Prove, in order to Place Judgment upon the Establishment and ROMAN CATHOLIC FAITH to Deter and Put Down Attacks against My Developing Faith and Faith Structure, and to stop Attempted Thefts and Harassment over the Course of My Lifetime. It is My Work.

Plaintiff REBECCATACOSAGRAY,CALIFORNIA has also filed suit against Defendants Deirdre Mulvihill and the Modesto Police Department [Mia, a Hispanic Female Officer] for Attempted Fraud in regards to My Work, and what shows as interference in My Work and Business as the Only True Place Location Expert of My Own Methodry, which I, Myself Developed through Direct Experience. I have been instrumental in many assistances to the American Government, including the Suggestion of a Location Chip that may be used in Bio-Physical Placement for Location of Earth Physicals upon Earth's Surface.

#### Argument

Stanislaus County Missing Person's List [First Leads]:

In Response to inquiries about Monetary, which did not, at all, have any bearing upon My Work, which is of My Life and is My Chosen Profession.
